#### III. A. **State & Local Anti-Terrorism Training (SLATT) Overview:**

presented by Marci Pesta, NCTC. A focus on the training objectives to enhance the preventive capabilities of the criminal justice community, to incorporate anti-terrorism techniques and to better recognize potential terrorism indicators and behavior.

B. **Healthcare Fraud:** presented by Jennifer Hogan, CARIE. A presentation to raise awareness of the impact of fraud on the quality of healthcare that older people receive.

C. **Distance Learning for Law Enforcement Professionals:** presented by Anthony Luongo, Temple University. This workshop will explore innovative, distance-learning technology solutions that bring training to the broader law enforcement community while overcoming limitations of cost, travel, and downtime.

D. **Youth Violence:** presented by Deanna Wilkinson, PhD, Temple University. A discussion of situational contexts where violent events occur, the social exchanges that lead to violence, and the decisions that determine their outcomes based on the conduction of qualitative life history interviews.

IV. A. **Auto Theft Prevention:** presented by Roy A. Miller, PATPA. Information on how to identify an owner "give-up," some innovative ways professional thieves are stealing autos, and to learn the motivation for why this crime has become so prevalent along with its social and economic impact.

B. **Handling Foreign Nationals:** presented by James Lawrence, U.S.D.S. A presentation by the U.S. Department of State, with reference materials for law enforcement officers when handling foreign nationals in the U.S. and the rights of consular officials to assist them.

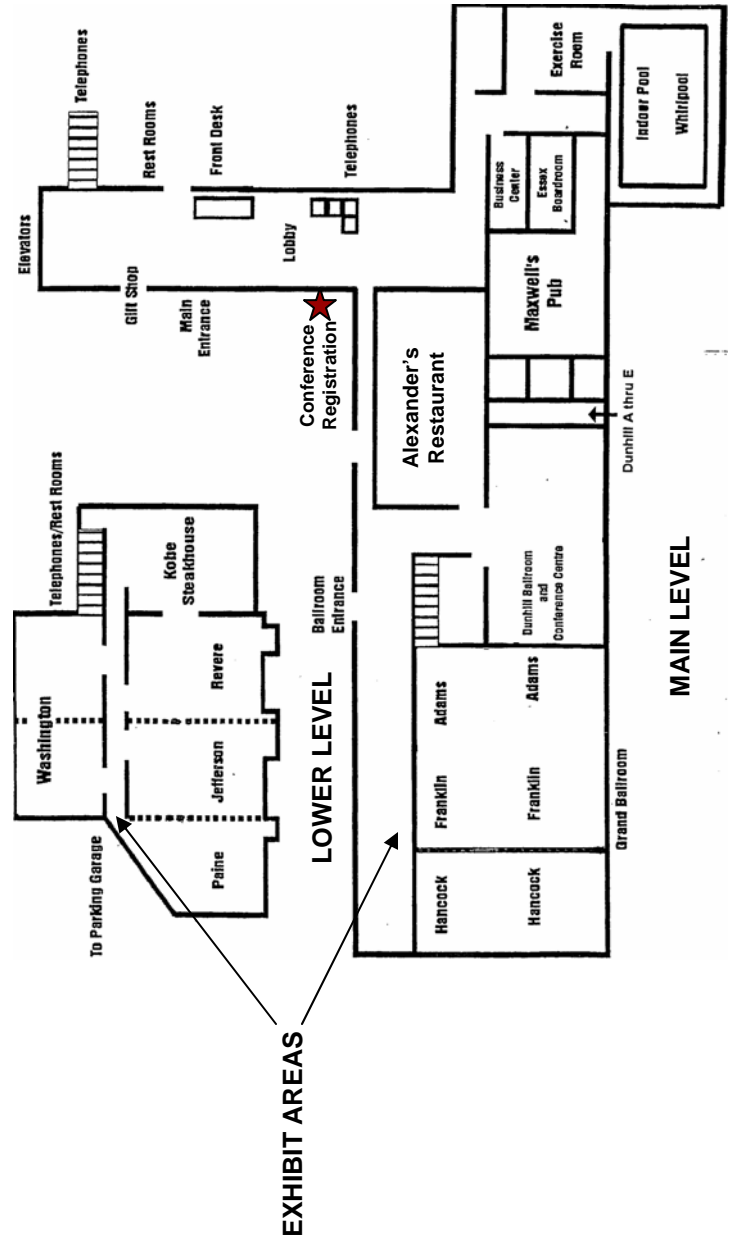

- I. A. **Internet Security Training Program I:** presented by Mary Dolan, Center for Safe Schools, Lt. Dennis McCauley, Abington P.D., and Lt. Rodney Manning, PSP. "Protecting Kids Online" parent and student programs with information to enhance internet safety knowledge, includes trainers manual, CD-ROM for school and community presentations. Participants *must attend* both workshops I.A & II.A for certification.
- B. **Terrorism Awareness and Prevention (TAP) I:** presented by Donald Numer, PCCD. Information about the realities and myths of terrorism, the importance for citizens to be alert, and what should be considered suspicious activity. Participants *must attend* both workshops I.B & II.B for certification.
- C. **PROTECT Act 2003 & Amber Alert:** presented by Jessica Sarra, National Center for Missing and Exploited Children, and Cpl. H. Wayne Sheppard, PSP. Act creates a national network of Amber plans across the U.S., linking ninety-one local, regional, and statewide programs; with individual law enforcement agencies playing a larger role in enforcement of this legislation.
- D. **Police Victim Services:** presented by Alan Harland, PhD, Temple University. This workshop will examine the range of services available to victims of crime and assess the role of the criminal court and law enforcement.
