Governor Edward G. Rendell appointed Walter M. Phillips Jr., Esquire as Chairman of the Pennsylvania Commission on Crime and Delinquency on March 22, 2004.

Mr. Phillips spent ten years as a prosecutor on the federal, state and local levels, serving as Assistant District Attorney in the Philadelphia District Attorney's Office, Assistant United States Attorney in the United States Attorney's Office for the Southern District of New York and Special Prosecutor/Deputy Attorney General for Police and Official Corruption in Philadelphia.

For the last two years that he was in the United States Attorney's Office in New York, Mr. Phillips served as Chief of that office's Narcotics Unit where he prosecuted international narcotics traffickers and major organized crime figures.

For three years, Mr. Phillips served as Chairman of the Philadelphia Ethics Board under Mayor William Green.

Currently, Mr. Phillips is of counsel to the law firm of Obermayer, Rebmann, Maxwell & Hippel, LLP, in Philadelphia where his areas of practice include white collar criminal defense, employment and commercial litigation.

Mr. Phillips received his undergraduate degree from Princeton University and his law degree from the University of California, Hastings College of the Law.

Michael J. Kane, Esq. was appointed Executive Director of the Pennsylvania Commission on Crime and Delinquency on June 20, 2005.

Mr. Kane joined PCCD after four years at the Pennsylvania Department of Revenue where he served as Director of the Bureau of Corporation Taxes and Deputy Secretary for Enforcement.

During his 18-year career as a federal and state prosecutor, Mr. Kane served as an Assistant U.S. Attorney for the Middle District of Pennsylvania and Senior Deputy Attorney General in the Pennsylvania Office of Attorney General. He was Chief Deputy District Attorney in Denver, Colorado, and served as a Special Prosecutor in Boulder, Colorado.

Mr. Kane is a 1975 graduate of St. Joseph's College (now University) in Philadelphia and a 1979 graduate of the University of Colorado Law School in Boulder, Colorado.

C. **Cyber Bullying:** presented by Charles J. Balogh, Jr. Crime Prevention Awareness Specialist, Luzerne County District Attorney's Office. The home is no longer a safe haven from schoolyard bullying. The internet allows peer-to-peer harassment to enter the home. Participants will examine the nature of bullying behavior. Short and long-term effects on the bully, victim and bystander will be presented. Strategies, tools and resources on how to encourage safe and ethical use of the internet will be offered.

D. **Funding Programs** – Presented by Sue Lanza, Robert Ardner, And Shay Larrisey of PCCD. Staff will present on the PCCD and other state and federal funding opportunities. The process for writing successful concept papers will also be discussed.

E. **D.A.R.E. Bullying Prevention** - The D.A.R.E. now offers two supplemental lessons on Bullying. These lessons are to be used only after the ten other lessons have been completed. This training is required in order to teach the Bullying Lessons, and attendance is limited only to D.A.R.E. officers.

III. A. **Terrorism - Homeland Concerns:** See II - A

C. **Protecting Kids Online:** presented by Charles J. Balogh, Jr., Crime Prevention Awareness Specialist, Luzerne County District Attorney's Office, and Mary Dolan, Center for Safe Schools. P.K.O. will provide law enforcement officers with essential information and helpful tools to present Internet safety topics in schools and communities. Online predators, cyber bullying and protecting personal information are just a few of the topics addressed. In addition, by completing the P.K.O. training, officers are eligible to request Internet safety educational resources for students and parents. **(Must attend session III-C & IV-C for certification.)**

D. **D.A.R.E. Bullying Prevention:** See II - E

IV. A. **Victim Services:** presented by Krista Hoffman and Wayne Hower, PCCD. In this presentation you'll learn everything you need to know about Pennsylvania's Victims Compensation Assistance Program. Who benefits, where the money comes from, and how law enforcement may be eligible for a wide range of financial help from this program and other state and federal programs when injured as a result of crime in the line of duty.

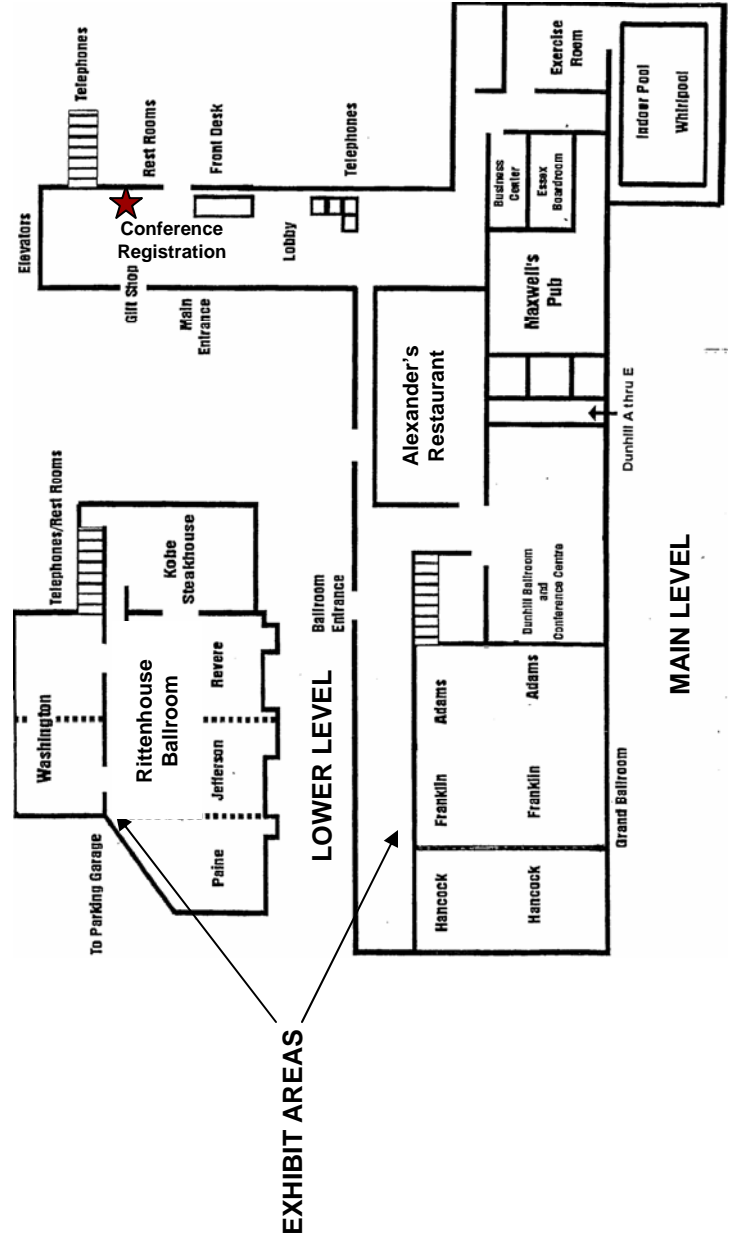

**Thursday, December 14**  
**Workshops I-II**

- I. A. **Bullying Prevention:** presented by Mary Dolan, Center for Safe Schools, Current youth surveys indicate an alarming number of students who report being bullied in school. This workshop will examine the definition of bullying, short-term and long-term effects, impact on school climate, link to the juvenile justice system and Pennsylvania law, and the role of law enforcement in regard to bullying prevention and intervention.
- B. **Identity Theft Panel:** Moderated by by Alexis Barbieri, Director of Public Protection Division, PA Attorney General's Office. Representatives from Health Insurers, Banking, Credit Cards and Schools will present information on their particular industry programs designed to protect consumers from identity theft.
- C. **G.R.E.A.T. Programs:** presented by Sgt. Steve Naughton, Philadelphia Police Department, G.R.E.A.T. Program, N.E. Regional Administrator. Presentation focuses on the Gang Resistance Education and Training (G.R.E.A.T.) Program, which is a school based prevention program, instructed by specifically trained Law Enforcement Officers. The Program is intended as an immunization against delinquency, youth violence, and gang membership. GREAT offers multiple prevention components for students and their families.
- D. **Revitalizing Neighborhood Watch:** presented by Chris Tutko, Director, and Robbi Woodson, Program Manager, National Sheriff's Association, "Neighborhood Watch Program." The events of 9/11 has caused the National Neighborhood Watch-USAonWatch Program, to focus on broadening the scope of Neighborhood Watch to include emergency preparedness, citizen awareness, and community education. This workshop will go through the revitalization and change to USAonWatch, resources provided by the national program in partnership with the Bureau of Justice Assistance, Office of Justice Programs, U.S. Department of Justice; understanding of partner organizations and available resources. This session will also offer a brief overview of NSA's Neighborhood Watch Toolkit and Training.

- II. A. **Terrorism – Homeland Concerns:** Presented by Officer David McCann, New Castle, Delaware Police Department. Information will be presented on readily available over-the-counter materials which could be used to disrupt our daily activities and sense of security when used for terrorist acts.
- B. **School Violence:** Presented by Peter D. Blauvelt, President and CEO of the National Alliance for Safe Schools. School safety reports required by state and federal laws often lack an accurate picture of violence and crime statistics inside area schools. Many PA and New Jersey districts did not report common offenses such as bullying or fighting
