4. In accordance with scientific custom, you agree to acknowledge the source of the Material in any publication reporting its use. You also agree to provide me with a copy of any publication that contains experimental results obtained through use of the Material.
5. You and those entitled to use the Material pursuant to Item 3 above, will do so in a safe manner and in compliance with all applicable laws and regulations, including all guidelines of The National Institutes of Health.
6. **THE ORIGINAL MATERIAL IS EXPERIMENTAL IN NATURE AND IS PROVIDED WITHOUT ANY WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. TEMPLE MAKES NO REPRESENTATION AND PROVIDES NO WARRANTY THAT THE USE OF THE MATERIAL WILL NOT INFRINGE ANY PATENT OR OTHER PROPRIETARY RIGHT.**
7. To the extent allowable under applicable laws, Institution agrees to indemnify, defend and hold harmless Temple and its trustees, officers, staff, representatives and agents against all damages, expenses (including without limitation legal expenses), claims, demands, suits or other actions arising from Institution's acceptance, use and disposal of the Material.
8. This agreement is not assignable.

To help defray the costs of producing the Original Material, Institution agrees to pay to Temple the non-refundable sum of \$ _____ within thirty (30) days of receipt of the Original Material by you.
