Guaranteed Access Parking and Receipt Form – EMPLOYEE

As a Guaranteed Access Parker, I hereby agree to abide by the following rules and regulations:

1. My parking privilege is solely for my use, convenience and at my own risk. Temple University assumes no responsibility for theft, fire, damage to or loss of use of either my vehicle or its accessories or its contents.

2. Cost of Parking is as follows:

The following is the payment schedule for Guaranteed Access parkers who are not on payroll deduction:

September 1 st	December 31 st	September 1 st

3. My hangtag, which must be displayed on the back of the rearview mirror inside my vehicle, and my activated Temple ID, are my means of admission to my assigned parking area. The absence of either of these will result in the assessment of the daily rate. At the Carlisle West Garage, my Temple ID will be used at the entrance/exit gate card readers and pedestrian door reader.
4. My parking privilege may be cancelled at any time upon completing a cancellation form and returning my hangtag. The university has the right to withdraw my privilege at any time with appropriate refund to me. **If I want my parking payroll deductions to be stopped, or for parking charges to stop accruing, I must return my hangtag to the Office of Parking Services.** My failure to pay the parking fee by the start of the parking period will result in an automatic cancellation of my parking privilege. **In case of a leave of absence such as medical, maternity, sabbatical etc., I will return my parking hangtag to the Office of Parking Services and complete a cancellation form.**
5. The following replacement fees will be assessed for lost/misplaced parking hangtags: \$20.00.
6. If it is determined that a Guaranteed Access parker is parking more than one vehicle at a time within the assigned area with his/her Temple ID or hangtag, the unauthorized vehicle will be towed at the owner's expense and the user will have his /her parking revoked, while disciplinary measures may also be taken.
