## INFORMATION REGARDING IMMUNIZATIONS FOR COLLEGE STUDENTS

*Illness can interrupt your school career. By reviewing and updating your immunization status now, you will have gone a long way towards preventing such a disruption.*

**Meningococcal** vaccine- The American College Health Association (ACHA) and Centers for Disease Control (CDC) recommend that all college students consider receiving this vaccine due to recent trend of an increase in the number of cases of meningococcal infection and meningitis in the 15-24 year old age group. This vaccine, marketed as **Menomune** or **Menactra**, helps protect against this disabling and potentially fatal disease.

**NOTE: Pennsylvania law requires that college students living in University housing receive the meningococcal vaccine or sign a waiver stating that they choose not to get the vaccine. You will not be allowed to move into your dormitory until you have provided us either proof of meningococcal vaccination or your signed waiver.**

**Measles/mumps/rubella (MMR)** - Outbreaks of measles continue to occur on college campuses in the U.S.; therefore, all college students should be immunized against these diseases.

**Varicella (chickenpox)** vaccine- Chickenpox in young adults can be dangerous. If you have not had the disease you should have the 2-dose series of this vaccine.

**Hepatitis B** vaccine -3-dose series. This is a contagious liver disease that is transmitted by unprotected sex, by needlesticks, and by blood or body fluid exposures. Most states already require this vaccine for children or teens.

**Influenza** vaccine- This vaccine is available by mid-October. Students with chronic illnesses, such as asthma or diabetes, should get this vaccine.

**Tetanus-Diphtheria-** Boosters are needed every ten years to maintain adequate level of protection.

**Hepatitis A** vaccine- 2-dose series. This is a contagious liver disease that is spread via contaminated food. This is recommended for travelers to high-risk areas, such as developing countries. It is also recommended for men who have sex with other men.
