PURPOSE: This Office of Developmental Programs (ODP) Informational Memo is to provide all interested parties with a list of current Agency with Choice Financial Management Service (AWC FMS) Providers supporting waiver participants and surrogates who have chosen to self-direct some or all of their Participant Directed Services (PDS) using the AWC FMS option. The AWC FMS Providers included are located throughout the Commonwealth and identified to provide services by Administrative Entity (AE). Currently this information is not available in the Services and Supports Directory.

As of July 1, 2009 ODP validated that each AE secured a qualified AWC FMS Provider to provide AWC FMS administrative services to waiver participants and surrogates who elect to use the AWC FMS option. In addition the same qualified AWC FMS providers have a signed "Provider Agreement" with ODP. Since the service of the AWC FMS provider is an administrative service, the choice of AWC FMS providers is not required or available. Therefore, the identified AWC FMS provider for each AE is the AWC FMS provider who will serve waiver participants interested in self directing PDS using the AWC FMS option.

These locally based AWC FMS providers are not to be confused with the statewide contracted Vendor Fiscal/Employer Agent Financial Management Service Organization (VF/EA FMS) *Acumen Fiscal Agent, LLC* which provides financial management services to waiver participants who elect to use the VF/EA FMS model.
