Describe the assessment method used to assess the learning outcome(s). Provide enough detail so that we understand the nature of the project.	For both of the 7-week student teacher placements (elementary and secondary), candidates are evaluated using a required standardized form known as the Pennsylvania Statewide Evaluation Form for Student Professional Knowledge and Practice (PDE Form 430). Using a combination of checklists, rubrics and space narrative feedback, the form utilizes a framework based on 5 Competency Domains: Planning and Preparation; Classroom Management; Instructional Delivery; Professional Conduct; Assessment; and Knowledge of Diverse Learners.
What were the findings from this assessment?	In the academic year 2015-2016, all (100%) of the students enrolled in Student Teaching scored either "Exemplary" or "Superior" on the rubrics in the following Competency Domains: Planning and Preparation; Classroom Environment; Instructional Delivery; and Professionalism. These Competency Domains are in direct correlation with Student Learning Outcomes 1, 3, 4, 5, 6, 9, 10, 11, 12, 13, 14, 15, and 16.
